- e. Agrees to pay all the fees required by the CAEQ to carry out the accreditation procedure, and understand that the processing of this accreditation application will only begin after payment for the required fees to the CAEQ, as well as the supplying of all the documents required in the *Regulations pertaining to Accreditation for Certification bodies* and by the competent authority.
